Waiting time to overcoating

PRIMING FOR SIKALASTIC 488/SL:

-Minimum overcoat time: 2-3 hours -Maximum overcoat time: 48 hours

PRIMING FOR SIKALASTIC 888 and 888 Hybrid:

-Minimum overcoat time: 2-3 hours -Maximum overcoat time: 8 hours

Please note all dry times mentioned are approximate and allowances should be considered for site specific conditions eg: substrate temperature, humidity, ambient temperature, product storage temperatures, air

flow etc

Drying time

Approx. 2hrs at 23°C, 50% rh

Applied product ready for use

For standard porous concrete applications, Sikalastic® PU Primer is ready for use from the pail. For substrates less porous, addition of up to 10% xylene can be added to assist in penetration of Sikalastic® PU Primer into the substrate. If in doubt, a site trial and adhesion test should be undertaken.

LIMITATIONS OF USE

Sikalastic® PU Primer cannot be used as a reactivation primer for the Sikalastic® polyurea membranes; abrasion and xylene wipe of polyurea membranes achieves better adhesion for reactivation
