#### DESCRIPTION

Sika<sup>®</sup> ViscoCrete<sup>®</sup>-10 is a third generation superplasticiser for concrete and mortar. It meets the requirements for high range water reducing superplasticisers according to AS1478.1-2000.

- High performance concrete
- Concrete in hot weather and with extended transportation and workability requirements

Fresh concrete must be cured properly and curing applied as early as possible.

#### **APPLICATION INFORMATION**

Recommended dosage	Recommended dosage for concrete: 250 ml to 2000 ml per 100 kg of total cementitious material. Optimum dosage should be determined by site trials.
Dispensing	Sika <sup>®</sup> ViscoCrete <sup>®</sup> -10 is added to the gauging water or added with it into the concrete mixer. To take advantage of the high water reduction, a wet mixing time, which is depending on the mixing conditions and mixer performance, of at least 60 seconds per cubic metre after the admixture addition is recommended. Sika <sup>®</sup> ViscoCrete <sup>®</sup> -10 shall not be added to dry cement.
Compatibility	Sika <sup>®</sup> ViscoCrete <sup>®</sup> can be used in conjunction with all the admixtures man- ufactured by Sika Australia PTY Limited with the exclusion of Sikament <sup>®</sup> NN.
