Storage conditions	The product must be stored in original, unopened and undamaged sealed packaging in dry conditions at temperatures between +5 °C and +35 °C.
Appearance and colour	Clear liquid

Specific advice	In addition to SikaControl®-301 PerFin, high quality concrete surfaces require: suitable concrete mix design, formwork and mould release agent, proper casting and compaction.
Recommended dosage	Typical dosage ranges between 1 litre and 3 litres per cubic metre. Optimum dosage and batching sequence should be always determined by site trials.
Dispensing	SikaControl®-301 PerFin is added to the gauging water or added with it into the concrete mixer. Do not add SikaControl®-301 PerFin to a dry mix.
Compatibility	SikaControl®-301 PerFin may be combined with many other Sika Concrete admixtures. Trials must always be carried out before combining products in specific
